ON THE APPLICATION of the Plaintiff, Sara Ramsay, without a hearing and on reading the materials filed by the lawyer for the Plaintiff, Michelle L. Segal:

THIS COURT ORDERS that:

1. legal fees in the amount of \$1,487,500.00, plus applicable taxes, with respect to the settlement agreement entered into with the defendants Panasonic Corporation, Panasonic Corporation of North America, Panasonic Canada Inc. and Sanyo Electric

Co., Ltd., dated October 12, 2020 (the "Settlement Agreement") are approved for BC, Ontario and Quebec Class Counsel (collectively, "Class Counsel");


2. payment of \$141,866.96, plus applicable taxes, is approved as a partial reimbursement against the total disbursements collectively incurred by Class Counsel;

3. Class Counsel's approved legal fees and applicable taxes, and disbursements and applicable taxes, shall be paid from the settlement funds, pursuant to the terms of the Settlement Agreement;

4. this Order is contingent upon parallel orders being made by the Ontario Superior Court of Justice and the Quebec Superior Court, and the terms of this Order shall not be effective unless and until such orders are made by the Ontario Superior Court of Justice and the Quebec Superior Court; and

5. endorsement of this Order by counsel for the Defendants shall be dispensed with.
